The terms & conditions are as under:-

- 1. The contract period will be from 07-12-2022 to 06-12-2023. Extendable for further two years on satisfactory/ good performance.
- 2. You are bound to deposit the following amount as rent of aforesaid Canteens/tuck Shops.

Schedule of payment:

- > Total payment of Rupees Rs.2,42,00,000/- have deposit within seven days after of issuance of Award Letter.
- 3. You are bound to provide the stamp paper (Rs.500/-) according to the Govt. instructions for execution of agreement in between the contractor and the institution according to terms & conditions.
- The electricity bill will be deposited on 5th of every month by you as determined by Electrical 4. Engineer of this institution.
- 5. You will display price list all items/ eatables /meals on prominent place according to the DC approved rates/ market rates duly approved by the canteen committee. Only slandered items will be allowed. You will not over-charge from the patients / attendants / public. In case of

overcharging / substandard items, the penalty upto Rs.20,000/- will be imposed in every case. In case of the imposition of three penalty the contract will be liable to be canceled by the institution Administration after hearing the contractor.

- 6. All type of sitting arrangement, furniture & crockery will be responsibility of the contractor & their will be no liability on contract & institution.
- 7. The location of canteen will be subject to change due to unavoidable circumstances as deemed necessary by hospital administration & no claim there of.
- 8. The canteen committee will check the quality of meals/ food/ eatables & cleanness of canteens/
 Tuck Shops. Failing to provide quality services the contract can be terminated without any
 notice.
- 9. Firm must abide by the instructions given by Punjab food authority (Copy attached).
- 10. You will not hire staff under age of 18 years according to the labour law / social security rules.
- 11. You will provide police verification of your hired staff.
- 12. You will provide copy of CNIC of the staff who will work on canteen/Tuck Shops to the office of the undersigned. Any replacement of staff will also be intimated accordingly.
- 13. Special attention will be paid to cleanliness of Canteen/tuck Shops & surrounding areas and the employees will wear neat and clean dress.
- 14. You will not sublet any portion of Canteen/tuck Shops. In case of noncompliance your contract will be cancel immediately.
- 15. If you fail to deposit the due amount after the receipt of letter, your security deposit will be forfeited and further action will be taken in light of terms & conditions and decision will be taken by purchase/ Canteen committee.
- 16. On expiry of contract i.e. 06-12-2023 at 23:59 PM, the contractor will be bound to handover the Canteen/Tuck Shops to the institutional authorities in satisfactory condition and it will be the ownership of the institution.
- 17. All Government Taxes will be paid by the contractor.
- 18. Your CDR amount of Rs.10,00,000/- already deposited by you in this office will be refundable after the audit of financial year 2022-23.
- In case of any dispute, decision of the Principal / Medical Superintendent, Sheikh Zayed Medical College / Hospital, Rahim Yar Khan will be final.
- 20. You shall also be bound to abide by the Policies/Instructions issued by the Government in this regard.
