Interested eligible bidders may get the bidding documents with scope of work from the Patient Welfare Model Pharmacy of this institution on submission of a written /computerized application in the name of principal/ Chairman PWMP on their letter head and a copy of CNIC along with payment of non-refundable fee of Rs.1000/-(One Thousand Only), as per schedule given below only during working hours.
2. Single stage-two envelopes bidding procedure will be followed.
3. Sealed bids are required to be brought in person by the authorized representative of the interested bidders on proposed dates up to 12:00 noon and will be opened on the same day at 12:30 pm in the presence of the bidders or their authorized representatives in the committee room of this institute. Late bids will be rejected.
4. All bids should be submitted in tape binding. All documents should contain proper page marking, attached in sequence as indicated for evaluation in the bidding documents and signature of authorized person. Moreover, signing and stamping of each page of bidding documents/form is mandatory.
5. A presentation to elaborate the manifestation of software will be arranged in the committee room of this Hospital for information regarding the services provided by the bidding firm and this must be compulsory for all participants.
6. In case the date of opening or last date of sale is declared as the public holiday by the Government or non working day due to any reason, the next official working day shall be deemed to be the date of sale, submission and opening of tenders accordingly, the time and venue shall be remain the same.
