1. BRIEF INTRODUCTION & OBJECTIVES

Sheikh Zayed Hospital in Rahim Yar Khan City caters to the population of the district as well is the neighboring remote areas. A major issue is the lack of capacity in terms of staffing and financial resources that restrain the ability of the hospital to provide efficient healthcare. Therefore, the existing Sheikh Zayed is overburdened by patient influx. The spoke hospital of Sheikh Zayed Hospital will lessen the burden on the main hospital. Also the spoke will make urgent hospital care accessible to the neighboring areas. People would not need to travel all the way to Sheikh Zayed hospital.

There is no trauma center from Sukhar to Bahawalpur. Many roadside accidental cases due to over speeding and careless driving will be brought to the trauma center of Sheikh Zayed Hospital, Rahim Yar Khan. These patients suffer from head injuries, blood loss and bone fractures. In many accidents the people of the said area got expired due to long distance from Sheikh Zayed Hospital Rahim Yar Khan and Victoria Hospital Bahawalpur. The establishment of 60 bedded spoke trauma center at Zahir Pir will reduce the mortality rate of accidental cases.

The beneficiary population for this project would be more than 7 million as it is a regional hub. There is only one trauma hospital catering to all specialties at present in this region. More than 7000 patients daily visit in OPD of Sheikh Zayed hospital, Rahim Yar Khan. At present the Sheikh Zayed Hospital is 120 bedded but daily more than 2000 patients visit Sheikh Zayed Emergency for urgent medical care. This project will address the felling of neglect in the minds of People of south region.
