



**Terms & Conditions of Tender for the Overhauling of Diesel Generator Cummins 550 KVA (IPB-34)**

1. Any offer not fulfilling the tender enquiry published in PPRA Website will straight away be ignored.
2. Offer will remain valid for 90 days from the date of opening of tender.
3. No offer will be considered if:-
  - I. The tender is received after the time & date fixed for its receipt.
  - II. The tender is unsigned.
  - III. The offer is ambiguous.
  - IV. The offer is conditional.
  - V. The firm is unregistered/black listed by any of the Government authority.
  - VI. The offer is received with shorter validity than required in the tender enquiry.
4. The vender will certify /undertake that the rates quoted against the tender are not more than the prices charged from any agency (Govt. / Private) in Pakistan previously. In case of any discrepancy, the vender/firm will refund the price charged in excess.
5. Specification can be changed / modified at time of negotiation meeting according to funds availability/approval by the institution.
6. Inspection will be carried out by the inspection committee of SZMC/SZH alongwith concerned end user.
7. Quoting firm would not be allowed to withdraw his/its offer during the validity period or after conclusion of contract/rate contract, whichever is earlier.
8. The Chairman Purchase Committee reserves the right to waive off/add/relax any particular condition at any stage, in public interest.
9. The tender form should be signed properly for acceptance of terms & conditions of the tender along with submitted quotation.
10. The firm should also be registered with FBR and Income Tax will be deducted from the payment to be made to contractor as per prevailing rules..

12. In case the offer is withdrawn, amended or revised during the validity period of the offer by the firm then its CDR will be be forfeited.
13. The supplier should attach cash receipts (in original or attested photo copies) in token of having purchased the tender.

15. Any conditional, ambiguous or incomplete offer in any respect will not be accepted. No supplementary or revised offer after the opening of the tenders shall be entertained.
16. The firms should indicate the complete address of its workshop, store or the place for the inspection of institutional technical/inspection committee/team.



17. Any erasing / cutting/crossing in the bid must be properly signed by the person signing the tender. All pages of the tender must also be properly signed. The offers with any over writing will not be accepted in any circumstances.
18. A certificate should be given by the firms that they will be responsible for the free replacement of items as well as work if the same is found to be substandard/working unsatisfactorily and or at variance with the specification given in the tender enquiry.
19. The Firm will make detailed examine/ inspection of the generator by its technical staff before quotation/participation in tender and shall be responsible for quotation rate of overhauling parts as well as work on turnkey basis.
20. A certificate should be submitted by the firm that the spare parts will be genuine, brand new and in the original packing of the manufacturer. The firm will deposited all spare parts in the main General Store of SZH for inspection and will replaced the said parts in the presence of Technical Staff of the institution.
21. 100% payment will be made through bank draft or crossed cheque which will be issued through the District Accounts Officer Rahim Yar Khan.
22. Rates should be quoted on free delivery at Consignee's end F.O.R. basis separately for Sheikh Zayed Medical College/Hospital, Rahim Yar Khan.
23. In case of any disagreement and dispute, the decision of the Purchase Committee of Sheikh Zayed Medical College/Hospital Rahim Yar Khan would be final.
24. Up to 05% of the final price of the ordered item will be deposited by the firm as security deposit.
25. The firm shall perform complete installation within given time in work order.
26. The detailed quotation for routine overhauling of generator must be comprised of separate rate for each item as well as work and any other unexpected additional item as well as work other than the routine overhauling of generator must be quoted in a separate table with rate. The payment will be made as per verified items as well as work by the inspection committee.
27. The firm shall be responsible to handover the overhauled generator on turnkey basis. No extra charges what so ever shall be claimed for any additional item as well as work other than the quoted rate for any expected additional part as well as work.
28. The firm shall undertake liability if there is any damage/loss due to installation made by the firm.


