The bidder shall furnish a bid security of 2% of estimated cost of tender in the form of call deposit receipt (CDR) in the name of the **Principal, Sheikh Zayed Medical College/Hospital, Rahim Yar Khan (Refundable)** in Pak rupees in financial bid and copy of CDR must attach with technical bid otherwise the bid will be rejected. Sealed bids are required to be brought in person by the authorized representative of the interested bidders on proposed dates up-to 10:30 am and will be opened on the same day at 11:00 am in the committee room of this institute in the presence of the bidders or their authorized representatives. Bids received after due time will not be entertained.
2. PPRA rules 2014 along-with all amendments will be followed.
3. Rates should be on F.O.R. basis as free delivery to the consignee's end in Pak rupees.

In case the date of opening or last date of sale is declared as the public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of sale and submission and opening of tenders accordingly, the time and venue shall remain the same.
6. Single stage- two envelop procedure, as per rule 38 (2) (a) of PPRA rules 2014, shall be applied.
