### TENDER INQUIRY FOR PURCHASE OF PARTS & ACCESSORIES OF BIOMEDICAL EQUIPMENT PICU/NICU AND REPAIR OF BIOMEDICAL EQUIPMENT PICU/NICU, SHEIKH ZAYED HOSPITAL, RAHIM YAR KHAN.

1. The tendering firm will visit the Biomedical Equipment Repair Department and after checking the equipment / machine to be repaired, will on EPADS.
2. The tendering firm will intimate the repair charges and also mention the part / parts with the cost of each required to be replaced from the equipment instrument, if any. The estimate without detail will not be accepted.
3. The tendering firm shall submit an affidavit on legal stamp paper Rs.100/- that their firm has not been black listed in the past on any ground by any Government (Federal, Provincial), a local body or a public sector organization.
4. A certificate should be given by the tendering firm that the parts required to be replaced shall be genuine / brand new from the manufacturer, in this connection, a certificate should be given by the tendering firm that they will be responsible for free replacement of faulty part / parts during the guarantee / warranty period which is one year from the receipt of repaired machine / equipment / instrument or as mentioned with the name of equipment.
5. The rates quoted will be valid for up to 06 months from the date of opening the tender.
6. The successful tendering firm will be bound to repair the equipment / instruments within stipulated time period after receipt of the confirmed work order, preferably on site (with in hospital premises) if the contractor fails to repair the article within the prescribed time limits given in the repair work order, the authority reserve the right to impose penalty in addition to forfeiture of security amount and black listing of the firm.
7. The tendering firm should quote their firm and final rates both in words as well as in figures.
8. The tendering firms for repair / tendering firm / quotations should submit 2 % call deposit against the estimated amount in Pakistani rupees in favor of Medical Superintendent, Sheikh Zayed Hospital, Rahim Yar Khan, which will be returned back under the rules. Any call deposit of the firm already with Sheikh Zayed Hospital, Rahim Yar Khan, is not considerable.
9. After completion of the work, a security deposit of 5% will be deducted under rules which will be released after successful completion of the warranty period.
10. Quote the final price inclusive of all kinds of taxes etc.
11. Replaced parts should be brand new imported from their manufacturer. The old parts replaced from the machine / equipment / instruments will be handed over to the Biomedical Equipment Repair Department of this hospital.
12. All pages of the tender must be properly signature. Any erasing/ cutting / crossing etc., appearing in the offer must also be properly signed by the tendering firm. Offers with any overwriting shall in no circumstances, will be accepted.

13. Following must be enclosed with the tender:

- Copy of the CNIC of authorized person of the firm.
- Call deposit
- Photocopy of GST, IT, Registration.
- Undertaking to refund any rate discrepancy as above.

14. Payment will be made after commissioning / handing over the equipment in functional status and satisfactory report from the inspection committee for repair.

15. In case of late repair of machine / equipment/ instrument beyond the period specified, penalty @ 0.067 % per day or the repair cost shall be imposed upon the tendering firm.

16. In cases of imported spare parts documents should be produced at the time of inspection and the firm will undertake that parts are genuine, branded new and in the original packing of the manufacturer.

17. Govt. tax deductions for purchase of items and repairing of items will be made as per PPRA/Govt. rules.

18. Successful tendering firm will have to give 95 % uptime guarantee for machinery and equipment breakdown time will extend the warranty period equally.

19. The firm should have test & tools equipment to calibrate equipment according to the manufacturer's specifications and standards.

20. The Medical Superintendent, Sheikh Zayed Hospital, Rahim Yar Khan, reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

21. In case of any dispute, decisions of Principal, Sheikh Zayed Medical College/Hospital, Rahim Yar Khan, will be final.




