## ADMISSION INTO FIRST YEAR MBBS

### Session 2025–2026 (For All Categories Seats)

In order to complete the admission process, the newly selected MBBS students (Session 2025–2026) are directed to report to the college on **02 / 02 / 2026**.

After medical examination and if declared **medically fit**, the candidate shall be required to deposit the following **original documents along with three (03) unattested photocopies of each** and **pay the remaining college dues for the academic session 2025–2026** as detailed below. **Failure to comply shall result in cancellation of admission for the session 2025–2026.**

#### LIST OF REQUIRED DOCUMENTS

1. Secondary School Certificate (SSC/Matric) or O-Level Equivalence Certificate, verified by IBCC.
2. Intermediate/HSSC or A-Level Equivalence Certificate or Detailed Marks Certificate of F.Sc (Pre-Medical), verified by IBCC.
3. Domicile Certificate (Original).
4. Character/Provisional Certificate from the institution last attended (Original).
5. Entry Test Result Card (Original).
6. Board Migration Certificate (for candidates whose board is other than Punjab)
7. Two (02) photocopies of CNIC/B-Form of the student and CNIC of father/guardian
8. Ten (10) passport-size photographs (unattested, not older than six months).
9. UHS Online Admission Form for Session 2025–2026 (hard copy).
10. Medical Certificate confirming vaccination against COVID-19, Tetanus, complete Hepatitis-B vaccination, and inoculation against Enteric Fever, issued by a registered medical practitioner (Government Medical Officer or PM&DC registered private practitioner), along with a printed copy of the COVID-19 vaccination certificate.
11. For foreign students only: HIV-Negative certificate from a recognized laboratory in Pakistan.
12. Surety Bond on e-stamp paper worth **Rs. 300/-**, duly attested by a Civil Judge / First Class Magistrate (Specimen Annexure-I).
13. Affidavit on stamp paper worth **Rs. 100/-**, duly attested by an Oath Commissioner (Specimen Annexure-II).
14. Relieving certificate from the previous institution along with an affidavit duly attested by the Principal (for candidates already admitted in MBBS/BDS Specimen Annex-III).
15. Disability Certificate (Original), if applicable, issued by the Provincial authority.
16. All students must scan their original documents along with a recent passport-size photograph and save them in a USB drive.
17. Submit all documents in a plastic bag in the above serial order. Clearly write Name, Father's Name, and Merit Serial Number on the bag with a bold marker.

### IMPORTANT INSTRUCTIONS

1. Original documents deposited with the college shall be returned after completion of the MBBS course.
2. All rules and regulations mentioned in the Prospectus of Government Medical & Dental Colleges (UHS) shall be strictly followed.
3. College dues must be deposited through challan issued by the Accounts Department and deposited only in **HBL, Sheikh Zayed Medical College Branch, Hospital Road, Rahim Yar Khan**. Pay orders, demand drafts, or personal cheques will not be accepted.
4. After payment of the hostel fee, hostel allotment will be done on the **same day**, strictly according to **merit**. All students are directed to strictly follow the **hostel rules and regulations** issued by the **University of Health Sciences (UHS)**, the **Principal**, and the **Chief Warden (Hostel) SZMC, R.Y.Khan**.
5. Boarder students must arrange their own light almirah, cot, and mattress.
6. Class of new 1<sup>st</sup> year MBBS session 2025-2026 will be started on **02<sup>nd</sup> February 2026 (Monday)**.
